Background

Advantages of Decentralized Charity:

All donation transactions are recorded on an immutable blockchain, allowing donors to track the flow of funds and ensure that donations are used for committed charitable projects. The decentralized structure eliminates intermediaries, reducing management fees and administrative expenses, enabling more donations to be directly allocated to charitable causes, thus enhancing the efficiency of fund utilization. Moreover, decentralized charity adopts a community governance model, allowing token holders to collectively decide how donations are used, ensuring fairness and democracy in donations and making it more likely to meet diverse charitable needs.

The issuance of the Childrens Aid Foundation token is based on a reflection of the opaque practices of traditional charitable organizations and recognition of the advantages of decentralized charity. By leveraging blockchain technology and smart contracts, we will ensure transparent use of donations and maximize social benefits, striving for the welfare of children worldwide.

Token Economic Model

The economic model of the Children's Aid Foundation token is designed to ensure liquidity, sustainability, and long-term support for child welfare initiatives. Leveraging the characteristics of blockchain technology, the model incorporates mechanisms such as transaction taxes, token burning, and liquidity rewards to ensure stable token value and incentivize community participation.

1. Initial Supply:

The total token supply is 2 billion, symbolizing the global child population, reflecting Children's Aid Foundation's commitment and concern for child welfare.

2. Transaction Taxes:

A 5% transaction tax is levied on each transaction. 2% is allocated to project operations and donations, 1% is for token burning, 1% flows back to the liquidity pool, and the remaining 1% is distributed in USDT to LP token holders of the CAF/WBNB trading pair. These tax revenues will support child welfare initiatives, enhance token liquidity, and incentivize community participation.

3. Token Burning:

The mechanism of burning a portion of tokens not only acts as a deflationary measure but also symbolizes our desire to reduce the number of children in need. 1% of tokens from each transaction are burned, gradually reducing the token supply and increasing token value.

4. Liquidity Rewards:

1% of each transaction flows back into the liquidity pool to increase token liquidity, improve transaction efficiency and speed. Additionally, users holding LP tokens of the CAF/WBNB trading pair receive automatic USDT dividends, further incentivizing community participation and holding.

5. Token Lockup Release Plan:

200,000,00 CAF will be unlocked and released to GATE exchange on 2024-04-01.

200,000,00 CAF will be unlocked and released to OKX exchange on 2024-06-01.

200,000,00 CAF will be unlocked and released to KUCOIN exchange on 2024-08-01.


200,000,00 CAF will be unlocked and released to BINANCE exchange on 2024-10-01.

200,000,00 CAF will be unlocked and released to COINBASE exchange on 2024-12-01.

The 180,000,000 CAF tokens will be allocated for rounds A, B, C, D, and E of public sales. The public sale price will be set at 95% of the unlocked token price at the time of each round. Payment for the public sale will be accepted in USDT. The public sale will last for 30 days after the unlocking of each round, with no limit on the amount per address. If any portion of the CAF tokens remains unsold after each round of public sale, the remaining tokens will continue to be locked for an additional two months.

6. Token Distribution Model:

50% of the Children's Aid Foundation tokens will be added to PancakeSwap liquidity, while the remaining 50% will be locked. Every two months, 20 million CAF tokens will be released to exchanges to provide basic liquidity. The remaining 180 million CAF tokens will be distributed in five rounds of public sales (ABCDE).



With the design of the above economic model, the Children's Aid Foundation token will maintain stable value and liquidity while providing continuous financial support for child welfare initiatives. Token transactions will directly benefit child welfare causes, creating more hope and possibilities for the future of children worldwide.
